In 2003, he graduated from the University of Chicago Law School (LL.M.). Thomas Rohner served as a law clerk at a District Court. In 2000, he was admitted to the bar. Prior to joining Pestalozzi, Thomas Rohner worked as an international associate for a major law firm in Washington DC. He became a partner in 2008.
